

MINUTES OF THE REGULAR MEETING OF THE BOARD OF PARK COMMISSIONERS OF  
THE CARY PARK DISTRICT, CARY, ILLINOIS, HELD IN THE COMMUNITY CENTER,  
255 BRIARGATE ROAD ON  
JUNE 24, 2021

***I. CALL TO ORDER***

Vice President Victor called the meeting to order at 7:00 PM.

***II. ROLL CALL***

Upon roll call the following Commissioners answered present: Mr. Stanko, Mrs. Carasso and Mrs. Victor.

***III. PLEDGE OF ALLEGIANCE TO THE FLAG***

The Pledge of Allegiance was recited.

***IV. MATTERS FROM THE PUBLIC***

Peter Spizziri spoke to his desire for dancing to be supported during the Summer Concert Series at Lions Park. He stated that he and many others have taken ball room dancing through the Park District and the addition of a dance floor near the band shell would be well used and appreciated by those that he knows. He asked the Board to consider his request.

***V. ITEMS FROM COMMISSIONERS***

Victor provided an update from the Cary Park Foundation. She stated that the Foundation Directors are interested in committing 50% of the cost necessary to put in the sand volleyball courts at the aquatic facility project at Cary-Grove Park. She stated the Foundation may also have interest in contributing to some of the power pedestal units, but needed more information prior to a decision.

Victor asked if any items were to be removed from the Consent Agenda. No items were requested for removal.

Roll call vote: Yes – Stanko, Carasso and Victor. No – None. Motion carried.

**VII.A. Any Items Removed From Consent Agenda**

**VII.B. Action Items**

**VII.B.1 -- Consider – Bid Results, Knotty Pines Park and Fox Trails Park.**

Jones stated that in 2020 the Knotty Pines Park bid had been released and the responses were rejected by the Board as they were over the project budget. He noted that the decision at that time was to wait until 2021 and rebid Knotty Pines Park as a joint bid project with Fox Trails Park playground replacement. Jones reminded that the equipment for Knotty Pines Park had been purchased in 2020 and received and stored by the Park District since that time.

Raica presented the bid results. Raica stated that the bid was posted and all legal requirements had been met. Raica stated the most responsive and qualified bid received was from Great Lakes Landscape Company of Bartlett in the amount of \$231,712.00. Raica stated that he had checked the references of the contractor and found all to speak highly of the contractor and their work. Raica stated that this contractor had bid on several similar past project of the Park District but were never the low bidder. Raica stated that he was recommending the contractor be approved by the Board. Raica stated that the work would begin in the early fall time frame and both playgrounds would be open to the public come spring 2022. Raica stated that the Board is also begin asked to consider the purchase of the playground equipment for Fox Trails Park which is being purchased via the cooperative purchasing program H-GACBuy.

Victor asked for discussion or questions from Commissioners. Hearing none, Victor asked for a motion.

**Stanko moved to approve the bid received from Great Lakes Landscape, Company. Bartlett, Illinois in the amount of \$231,712.00 as the most qualified and responsible low bid for the Fox Trails and Knotty Pines Park playground installations and site improvements. Second by Carasso.**

Roll call vote: Yes – Stanko, Carasso and Victor. No – None. Motion carried.

**Stanko moved to approve the purchase of playground equipment to be installed at Fox Trails Parks in an amount not to exceed \$62,142.00 from Landscape Structures, Inc. via the HGACBuy-Houston – Galveston Area Council Buy purchasing alliance program. Second by Carasso.**

Roll call vote: Yes – Stanko, Carasso and Victor. No – None. Motion carried.

**VII.B.2 -- Consider – R-2021-22-01, July 2021 as National Parks and Recreation Month.**

Jones stated that each July, the National Park and Recreation Association designates July as National Parks and Recreation Month. He stated that the resolution for consideration recognizes July in this manner.

Victor asked for discussion or questions from Commissioners. Hearing none, Victor asked for a motion.

***Stanko moved to approve R-2021-22-01, July 2021 as National Parks and Recreation Month. Second by Carasso.***

Roll call vote: Yes – Stanko, Carasso and Victor. No – None. Motion carried.

***VIII. Executive Director Report***

Jones updated that the roofing bid for the aquatic project had been released again after the results of the first bid process were rejected by the Board. He stated that Lamp believes there may be savings of \$30,000+ by rebidding and therefore the decision was made to pursue it. Jones stated that on July 8 the bids will be opened and that at the COW meeting that evening he should have an update for the Board.

Jones updated on the aquatic facility project at Cary-Grove Park. Raica updated on the trail project at Hoffman Park.

Victor asked for a motion to adjourn.
