- 6. The Board can temporarily modify or suspend these guidelines during a meeting if so determined by a majority vote of those present.

Mike DiOrio expressed his support for the possibility of striping pickle ball courts at Lions Park during the parking lot replacement project. He stated the parking lot at Lions Park, specifically in the lower section near the old preschool, is the perfect spot for the courts being that there are no residential homes surrounding that area and that space is not particularly busy. He also recommended adding lights so the courts can be used at night as well. DiOrio shared he plays a lot of pickle ball and is very familiar with the courts in the neighboring towns. Jones stated at the October 19, 2023 Committee of the Whole meeting, staff was directed to conduct the sale of the annual rollover bonds and bring the results of the sale direct to the Board for consideration. Krueger introduced Dan Forbes of Speer Financial, who presented the results of the sale to the Board. Forbes stated that it was a competitive sale as four total bids were received, three of the bids coming in very close to each other. Forbes further stated that Speer is recommending the Board accept the bid from Time Bank of Park Ridge, IL.

## Carasso moved to accept bid from Time Bank, Park Ridge, IL for the Cary Park District's General Obligation Limited Tax Park Bonds, Series 2023 as presented. Second by Stanko.

Victor reported property tax revenues make up about 57% of the Park District's total revenue with the additional 43% coming from program fees; golf fees, charges and instruction; merchandise, food and beverage sales; and grants. This year the District is proposing an overall levy of \$5,799,025.34, which is 7.31% increase over last year's tax extension.

Victor finished by stating, at this time we are accepting any comments from the public on this year's proposed levy.

President Victor opened the floor to public comment. Hearing no public comments, Victor stated she would leave the floor open to public comment until 6:59 PM. Jones stated he did not receive any public comments via phone or email prior to the public hearing. After hearing no public comments, Victor closed the public comment period.
