RE: FY 2026-27 Annual Meeting Items for Consideration

Providing exceptional recreation, parks and open space opportunities.

Introduction

Each year the Board is required to hold an Annual Meeting.

Background

During this meeting the Board addresses several appointments, designations, titles and schedules.

IV. Nomination/Election of Officers

The Board considers the positions of President and Vice-President for the upcoming year. During many but not all previous occasions, both positions have served two consecutive years with a re-election for the second year. There is no limit to the number of times an individual may serve in either role, consecutively or in total. Current President Frangiamore and Vice President Renner assumed the duties of President and Vice President in May 2024.

President Frangiamore should open the floor to nominations. The President may determine if nominations are to be taken for each position separately or as a slate for both positions. After accepting nomination(s) and confirming them with a second, President Frangiamore should close the nomination period. If multiple nominations are received, a vote on each of the nominated individuals or slate of individuals should be conducted to reduce the field to one individual or one slate of individuals. Then a final action vote should be taken to appoint/approve that single individual or slate of individuals.

Motion(s) To Consider

*Move to approve *** as President for FY2026-27 of the Board of Commissioners.*

*Move to approve *** as Vice-President for FY2026-27 of the Board of Commissioners.*

OR

*Move to approve *** as President and *** as Vice-President for FY2026-27 of the Board of Commissioners.*

If Frangiamore is re-elected President, the next paragraph will not apply.

If someone other than Frangiamore is elected President, the President's role in "running" meeting would transfer immediately to the newly elected President. At times, the newly elected President has deferred to the sitting President to continue running the Annual Meeting to its completion. This is not by policy, but by past practice depending on who is the sitting President and who is the newly elected President and their comfort with the above approach.

V. Appointment of Positions

Per policy 1-007a, the President should nominate individuals or by job title to the Board for consideration. Because the President position may have changed hands just prior to this agenda item, the recommendations below are consistent with past approach to these appointments.
